

DUST CONTROL PERMIT FOR LIGNIN SULFONATE TREATMENT

The approval of this application directs Dunkerton Co-Op of Dunkerton, IA to apply two Lignin Sulfonate Treatments, 18 feet wide, on a (minimum 400 feet) _____ portion of county rock road extending _____ feet (W)(N) _____ feet (S)(E) of the center of our drive located on the (N)(S)(E)(W) Side of Section _____ in _____ Township. Lignin Sulfonate is shipped in a solution containing 50% solids. Both Spring and Summer treatments of Lignin Sulfonate shall be applied to the road surface at a rate of one gallon per lineal foot with a minimum mix ratio of 26% solids by weight. First time applicants may elect to receive a double shot on the first application at an additional fee of half the double application. Dunkerton Co-Op will handle the filling out of permits, collect fees, send copies to Fayette County, notify Fayette County of application dates, apply the treatments, and answer further questions from applicants. Fayette County will furnish signs upon request for the applicant to use in staking the limits of the dust treatment and maintain and shape the road prior to each application. The treated portion of the road will not be maintained before October 15th as long as it is in a smooth condition. If pot holes develop, maintaining will be done using the material within the limits of the dust treatment when moisture is present. Iowa law specifies, "the purpose of a public highway is to serve the traveling public". Dust treatments after October 15th or those left rough by residents will be scarified and maintained as a rock surface.

NOTE: Please place a colored flag or stake at the spot you want your dust control to start. Our trucks are calibrated to measure out the number of feet applied. Please have your name on the mailbox or prominently displayed so we can be sure we have the correct location.

Show the location of building site, location of entrance and location where treatment is requested with respect to entrance. For sub-divisions, give the name of street of street and designate the limits of coverage requested.

If there is no map supplied or visible stakes at the location, drivers will use best judgment as to placement of dust control.

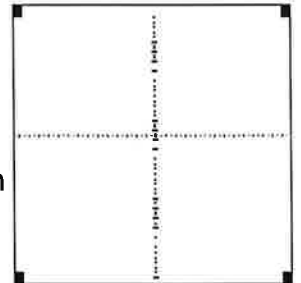
